This is a non-union position and reports to the Children's Services Manager. This position is responsible for coordinating a broad range of high quality early years programs and services.

Duties:

- In consultation with the Children's Services Manager, plan and integrate strategic initiatives in the on-going development and transition of the EarlyON Child and Family Centres while working with community partners.
- Develop service contracts and purchase of service agreements with lead agencies.
- Coordinate and assist the Children's Services Manager with the implementation and evaluation of funding policy and program guidelines to support the Hastings County Early Years Service Plan.
- Assist with the implementation of a wide range of core and customized programs and services in the early years sector.
- Under the direction of the Children's Services Manager, oversee EarlyON programs and services including budgeting, resource allocation, evaluation, partnership development and marking.
- Research, develop and recommend short and long-term service delivery strategies in accordance with the Children's Services strategic directions, guidelines and legislative program requirements.
- Coordinate and facilitate meetings, info sessions and focus groups in the development of an expanded system to ensure stakeholder engagement and support change management practices to build community capacity in a collaborative manner.
- Assist with the implementation and ongoing success of the EarlyON Child and Family Centres systems work plan that monitors the execution of clearly articulated milestones and actions.
- Ensure ongoing compliance with all Ministry initiatives, reporting, policies and procedures as it relates to the Early Learning and Child Care(ELCC) transformation.

Qualifications:

- Early Childhood Education diploma and/or university degree in a relevant field. (eg. Human Services, Child Development, Community Development, Social Services.
- Minimum three years supervisory experience.
- Knowledge of early childhood development.
- Demonstrated competence in project coordination, program implementation, process improvement, change management and program evaluation, ideally in a children's services system.
- Strong knowledge of Early Learning and Child Care provincial legislation and Ontario Early Years framework, including How Does Learning Happen.
- Demonstrated experience in community engagement and working collaboratively with community partners.
- Understanding of culturally responsive Indigenous pedagogy and its importance.
- Excellent written and verbal communication, facilitation and presentation skills.
