What is being proposed? The Municipality is seeking input on a development application within 60 metres of your property that would require a minor variance.

The purpose and effect of the Minor Variance(s): To allow the expansion of an existing dwelling from the Municipality's Comprehensive Zoning By-law 21-2012 to allow the following reliefs:

1. Permit a side yard setback of 4.2 metres (13.7 feet) whereas a setback of 6.7 metres (22.0 feet) exists.
2. Permit the established front yard setback to be applicable to the proposed additions to the dwelling.

A key map is attached.

The effect of this permission is to permit the expansion of an existing legal non-conforming dwelling.

Why? This meeting is an opportunity to learn about the proposed minor variance and provide feedback.

Written comments are requested five (5) days prior to the meeting so that they can be reviewed by Planning Staff before a final recommendation report is prepared and so they may be read at the public meeting for the benefit of everyone in attendance.

What can I expect at the Public Meeting?

The public meeting is an opportunity for members of the public to learn more about the proposal. Attendees can hear a brief presentation about the proposal, ask questions, and/or make verbal or written statements either in favour of, or in opposition to the proposed minor variance. At the meeting members of the public will also hear a summary of any comments received about the proposed development prior to the public meeting.

When will a decision be made?

A decision on this proposal has NOT been made at this point and will NOT be made at the Public Meeting. After reviewing the application and any comments received, staff will bring a recommendation on this proposal to a Council meeting, which may occur following the public meeting on the same date.

Want to be notified of a decision?

You must make a request in writing, to the Clerk, if you wish to receive a notice of any decision of Council on this proposal.

Any specified person or public body may appeal the above-noted minor variance to the Ontario Land Tribunal by filing with the Clerk of the Township of Faraday by no later than the specified date on the Notice of Decision. A notice of appeal and the reasons for the appeal, together with the required fee of \$400.00, paid by certified cheque or money order, made payable to the Ontario Minister of Finance. If you wish to appeal to the Ontario Land Tribunal, a copy of an appeal form is available from their website at www.olt.gov.on.ca or by calling toll-free 800-855-1155.

Only individuals, corporations, and public bodies may appeal a minor variance to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf. No person or public body shall be added as a party to the hearing of the appeal unless, before the By-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

Please note that third parties (anyone who is not a specified person or public body as defined in the Planning Act) do not have the right to appeal a decision for a minor variance to the Ontario Land Tribunal.

If no notice of appeal is filed within the above-described time period, the minor variance shall be deemed to have come into force on the day it was passed.

A note about information you may submit to the Township:

Individuals who submit letters and other information to Council should be aware that any personal information contained within their communications may become part of the public record and may be made available through the Council agenda process.

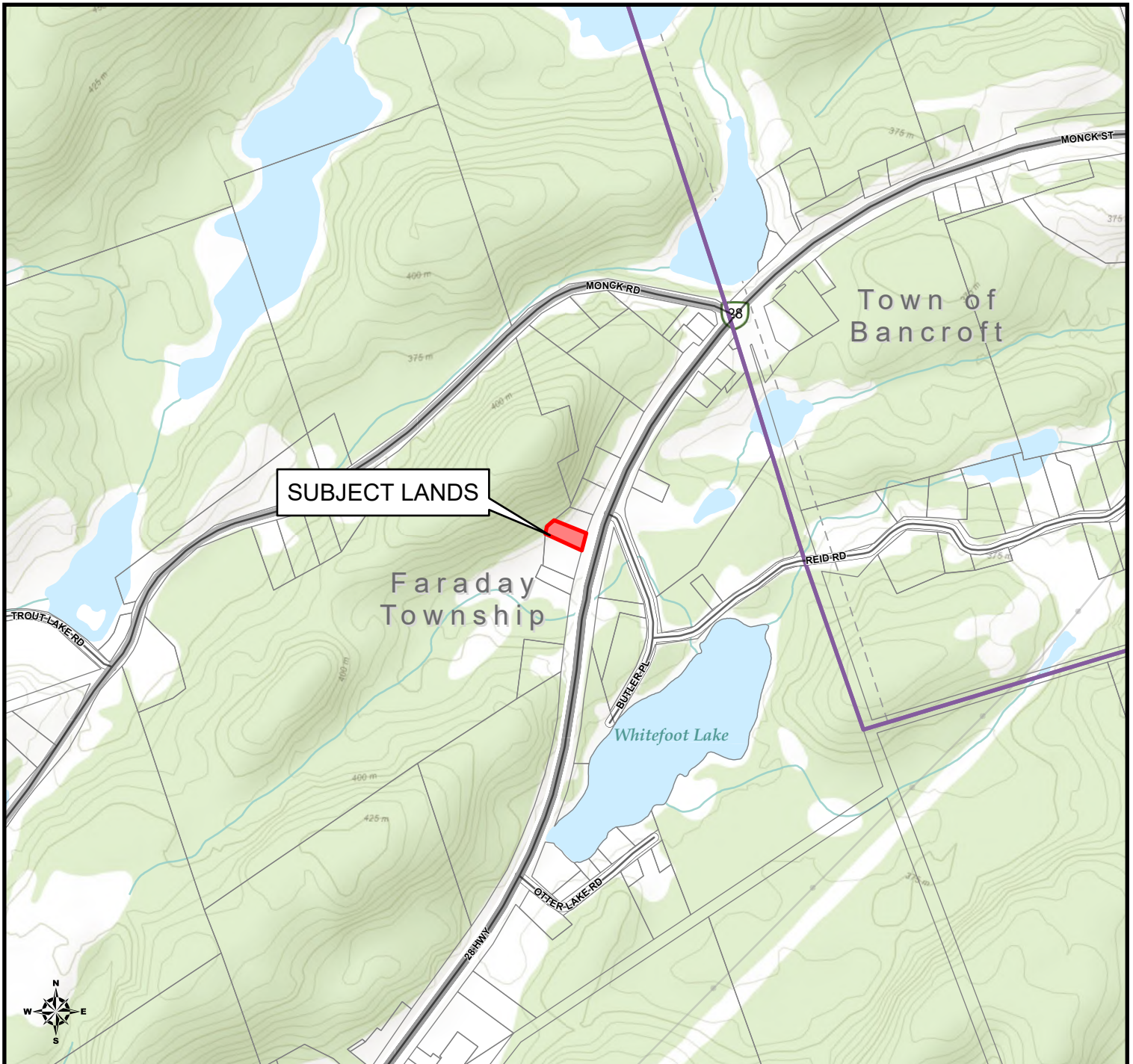
