**DUTIES:**

- Nursing or related work including the administration of medications and supervision of staff. Must be able to work any shift.

**QUALIFICATIONS:**

- Must hold a current Registered Practical Nurse Certificate of Competency and be certified to give medications.
- Must have demonstrated ability:
  - to effectively supervise other staff in a team environment;
  - to provide, with minimal supervision the appropriate care to meet the needs of the elderly;
  - to provide assistance to other staff and participate in resident care with a team approach;
  - to effectively communicate with the elderly, fellow employees and the general public, and;
  - to accurately follow written procedures and verbal instructions from supervisory staff, and to willingly carry out any and all assigned duties
  - regularly and punctually attend work

Centennial Manor has been approved for the **Community Commitment Program for Nurses (CCPN)** and the successful candidate for this position may be eligible for up to \$25,000 in funding. To be eligible for the CCPN, a nurse must:

- Not have been employed as a nurse in Ontario in the six months prior to being hired;
- Hold a certificate of Registration in good standing from the College of Nurses of Ontario;
- Begin employment no later than March 31, 2024;
- Commit to 24 -months of employment at a full-time work schedule offered by the employer; and
- Not simultaneously receive funds from the Ministry of Health for the Tuition Support Program for Nurses.
